Natwick presented the 1st reading of Resolution 2023-01. The Resolution is needed due to an increase in our Big Sioux Community water contract. The Town's last increase in water rates & fees was in 2013. Rates affected are the Water Service Fee will increase from \$15.00 per month to \$20.00 per month. Late Fees will increase from \$20.00 per month to \$25.00 per month. New rates will be effective on January 1, 2024.

Council reviewed August financials & September billing vouchers. Motion was made by McManus & seconded by Bjorklund to approve & pay the monthly claims as follows: A-1 Portable Toilets-\$210.00 Parks Expense; Big Sioux Community Water System-\$979.60 September Water Purchases; Big Sioux Community Water System-\$1,270.00 Sewer & Water Operator Contract; Bud's Clean-up-\$924.00 Garbage Contract; Dakota Curb & Stone-\$5,714.30 Parks Expense; Ensz Fencing-\$11,222.04 Sewer Expense; IRS-\$897.18 Payroll Taxes; ITC-\$140.88 Phone, Fax and Internet; Madison Daily Leader-\$28.05 Publications; Office Peeps-\$156.02 Office Expense; Ottertail Power Company-\$584.79 Electric & Street Lighting; Runnings Supply-\$145.26 Building Maintenance Expense; SD Dept of Revenue-\$139.05 Sales Tax Expense; Timmer Supply-\$8.41 Street Expense; Executive Administration Council-\$1,253.37 Salaries & Wages; Financial Administration-\$1,940.26 Salaries & Wages; Charles Wold-\$129.29 Park Wages.
