Vogt motioned to nominate Ryan McManus as Water & Sewer Supervisor. Bjorklund seconded. Council reconvened after nomination of new officers and supervisors.

Natwick applied for a West Nile Grant with the State of South Dakota. Award amount is pending.

Bjorklund motioned and McManus seconded to change council meeting dates to Wednesdays from June 2023 through September 2023. The council meeting schedule can be found on the Town's web-site, www.wentworthsd.com.

Bjorklund motioned and McManus seconded to move \$8,500.00 from the Contingency Fund to General Government Buildings, Repairs & Maintenance.

The Town received a grant for Park upgrades. The new playground set is installed.
