The Wentworth Town Council met in regular session on Wednesday, July 19, 2023 at 6:00 p.m. via tele-conference. President Roger Vogt called the meeting to order with the following Council members present for roll call: Joshua Bjorklund, Ryan McManus & Roger Vogt. Also present was Trish Natwick, Finance Officer.

GRANTS - Natwick informed Council that the Town was awarded a West Nile Grant in the amount of \$1,297.00.

WATER LOSS REPORT – Natwick informed council that the Town’s water loss average for the first six months of this year is 8.16%. Big Sioux Water will be doing annual readings the first week of August.
