

## WENTWORTH TOWN COUNCIL MINUTES

The Wentworth Town Council met in regular session on Monday, January 20, 2025, at 6:00 p.m. via tele-conference. President Roger Vogt called the meeting to order with the following Council members present for roll call: Josh Bjorklund, Ryan McManus and Roger Vogt. Also present was Trish Natwick, Finance Officer.

There were no additions or corrections to the Agenda.

Motion was made by McManus and seconded by Bjorklund to approve the Minutes of the December 16, 2024, Council meeting as written.

NEW BUSINESS:

There were no increases or changes to 2025 employee & council wages. President-Regular meeting \$220.00, \$140.00-Special meeting; Trustees-Regular meeting \$180.00- \$110.00 Special meeting; Streets and Water & Sewer Maintenance \$21.75/hour; Snow Removal & Mowing \$21.75/hour; Assistant Finance Officer \$21.75/hour and Finance Officer \$22,824.00 per year, \$110.00 Special meeting.

Bjorklund motioned, McManus seconded to designate the Madison Daily Leader as the Town's legal publication, as required by SDCL 9-12-6.

McManus motioned, Bjorklund seconded to designate First Interstate Bank and SD Public Funds Investment Trust as the legal depositories for the Town of Wentworth.

Natwick presented the Town's property inventory to the Board as of December 31, 2024, as required by South Dakota Codified Law 5-24-1. Bjorklund motioned and McManus seconded to accept the December 31, 2024 property inventory as written.

The following office will become vacant due to the expiration of the present term of office for Trustee – Three Year Term. Circulation of nominating petitions may begin on January 31, 2025. The Finance Office will be open on Friday, January 31st from 2:00 pm to 5:00 pm to accommodate any resident desiring a petition. Petitions may also be picked up at the Finance Office at 216 S Main Avenue between the hours of 12:00 pm and 3:00 pm on Mondays and Wednesdays. In municipalities of the third class, the nominating petition must be signed by not less than ten registered voters of the municipality. Petitioner must live within city limits and must be an active registered voter. The deadline for filing a nominating petition with the Finance Officer is February 28, 2025, between the hours of 2:00 pm and 5:00 pm.

Council reviewed December financials and January billing vouchers.
